## MONTHLY MEETING MINUTES

October 16, 2012

**MEETING CALL TO ORDER:** Meeting was called to order by Chief Constable Bob "Ironhorse" Stevenson at 7:30 pm.

**PLEDGE TO THE FLAG:** Pledge was led by Brother Fred Wilcox.

**ROLL CALL OF BOARD MEMBERS** Roll was taken, and those present and absent were so noted: Chief Constable, Bob "Ironhorse" Stevenson; Constable, Russell "Christ" Holder; Clerk, Gene "Bean Counter" Breeland; Bailiff, Dan McCarthy; Master at Arms, Keith Kenne; Juror Foreman, Fred Wilcox; Juror / Asst Jailer, Dave Barnett; Jailer, Kevin "Stinky" Jenkins; Juror, Gene Jenkins.

**CHIEF CONSTABLE'S REPORT** Brother "Ironhorse" Stevenson reported:

1. Discussed the upcoming Widders Ball at the IOOF Hall in Sacramento on Saturday, October 27, 2012. Flyers are going in the mail.
2. A list was circulated for sign-up to provide food for the Widder's Ball. Ironhorse is coordinating.
3. Bob reminded all in attendance of the Graveyard Watch, and the fact that it is not a sanctioned event.
4. Bob said that the ride to the wall was a great event and that Floyd cooked up an excellent lunch. He also thanked Brother Walter Hale for his help in transporting the food to Murphy's.
5. D & O Coverage will be secured at a cost of \$950.
6. A decision has been made to move the monthly meetings to the VFW Hall in West Sacramento starting in December. The Board Meeting will be on the First Monday and the Regular Meeting on the Third Monday.

**CONSTABLE'S REPORT** Brother Russell "Christ" Holder reported that the ride to the wall was a very successful event and that he was looking to expand it to include more chapters and make it an annual trip.

**BAILIFF'S REPORT** Bailiff Dan McCarthy reported Beginning Balance as of 08/31/12 of \$8,296.42 plus receipts of \$126.00 less expenses of \$132.62 leaving a calculated balance as of 09/30/12 of \$8,289.80.

**COURT CLERK'S REPORT** Brother Gene "Bean Counter" Breeland read the minutes of the previous general meeting Moved by Don "Peanut Butter" Breeland that they be accepted as read. Motion was seconded and passed.

**HISTORIAN'S REPORT** Brother Don "Peanut Butter" Breeland gave an excellent report on the fiftieth anniversary of the Cuban Missile Crises and the possible impact upon the assassination of President John Kennedy. He also talked about the origin of red and black as the colors of E Clampus Vitus and the fact that the first organization so

adorned was a militia known as the Sacramento Hussars a unit of mounted lancers who were assigned to guard gold shipments out of Camp Washington which was located in what is now West Sacramento.
