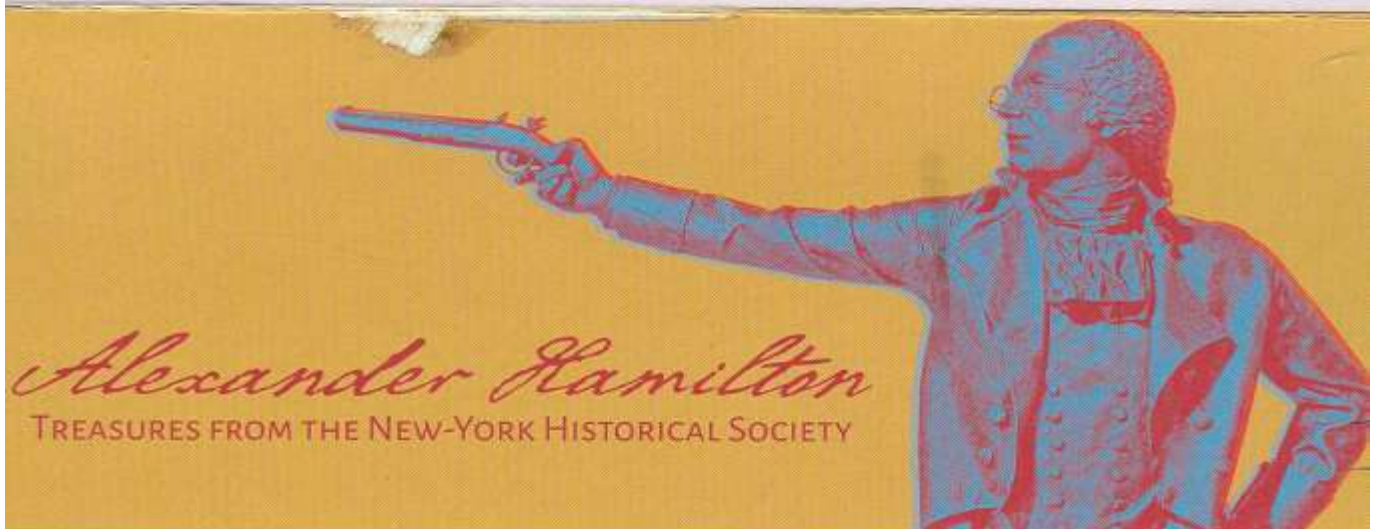

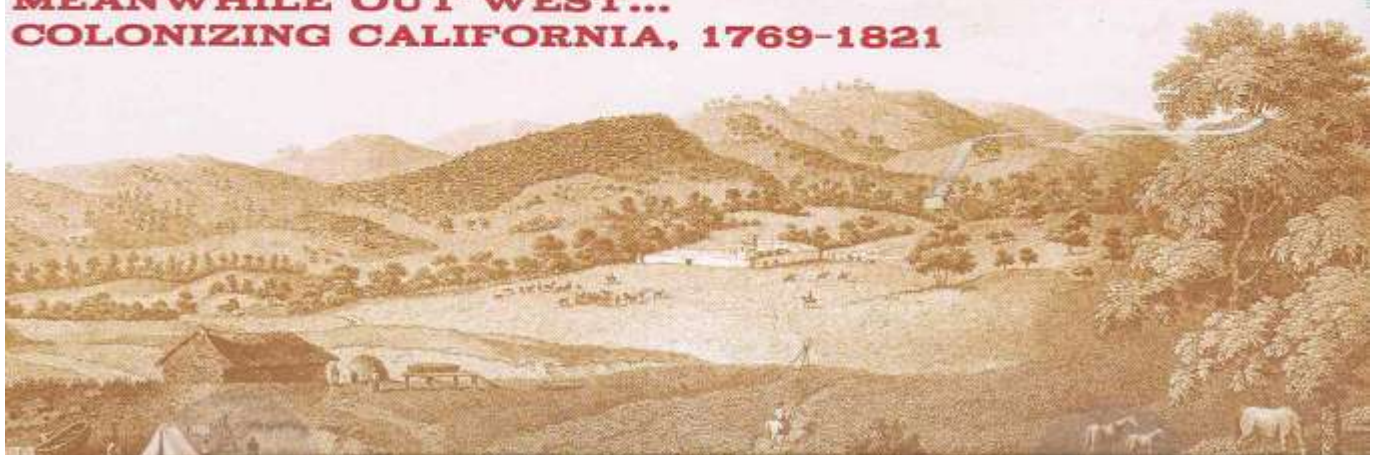

This exhibition explores the period through manuscripts, books, paintings, and artifacts from the collections of the California Historical Society as well as the Autry Museum of the American West, Mission Dolores, and the Phoebe A. Hearst Museum of Anthropology.

Notification of an assessed penalty will be sent to the entity by the Franchise Tax Board. If the required statement is not filed by the end of the next filing period, the entity may be **suspended** or **forfeited**.
